Gar Alperovitz is the author of *America Beyond Capitalism: Reclaiming Our Wealth, Our Liberty and Our Democracy*, *The Decision to Use the Atomic Bomb*, *Rebuilding America* (with Jeff Faux), *Cold War Essays* and the critically acclaimed *Atomic Diplomacy: Hiroshima and Potsdam: The Use of the Atomic Bomb and the American Confrontation with Soviet Power*. John Burroughs is Executive Director of the New York-based Lawyers' Committee on Nuclear Policy (LNCP) and Adjunct Professor of International Law at Rutgers Law School, Newark. In 1998, he represented LNCP at the negotiations on the International Criminal Court in Rome, and in 1995, he was the nongovernmental legal coordinator at the hearings on nuclear weapons before the International Court of Justice. He is author of *The Legality of Threat or Use of Nuclear Weapons: A Guide to the Historic Opinion of the International Court of Justice* (Transaction Publishers, 1998), and co-editor of *Rule of Power or Rule of Law? An Assessment of U.S. Policies and Actions Regarding Security-Related Treaties* (Apex Press, 2003).

Anabel Dwyer teaches Human Rights and Humanitarian Law at the Thomas M. Cooley Law School in Michigan. She has been a defendant and defense attorney in cases of civil resistance to nuclear weapons and is on the Board of the Lawyers' Committee on Nuclear Policy. David Dwyer is a Professor of Anthropology and African Studies at Michigan State University. Richard Falk is professor emeritus of political science at Princeton University. Seymour Melman is Professor Emeritus of Industrial Engineering at Columbia University's School of Engineering and Applied Science. He has written widely on economics, defense policy, and engineering. Anna Nelson is Distinguished Adjunct Historian in Residence at American University. She has published more than thirty articles and book chapters on the national security process of the early Cold War. Her most recent book is *Secret Agents: President Polk and the Search for Peace with Mexico*.

Terrence Edward Paupp is National Chancellor of the United States *for the* International Association of Educators for World Peace and is professor of politics and international law, National University, San Diego. He is the author of *Achieving Inclusionary Governance: Advancing Peace and Development in First and Third World Nations* (2000) and has published articles on civil rights, human rights, and constitutional war powers in *The Urban League Review* and *The Journal of Contemporary Legal Issues* (USD.) Most recently, he contributed to *Rushing to Armageddon: The Shocking Truth about Canada, Missile Defense, and Star Wars* (2004).

Marcus Raskin is the author or editor of over a dozen books on a broad range of topics including national security (*After Twenty Years: Alternatives to the Cold War in Europe, The Politics of National Security*), philosophy (*Being and Doing, The Common Good, New Ways of Knowing, and Visions and Revisions*), and American politics generally (*Essays of a Citizen* and *Notes on the Old System*). He has worked in the executive branch as a member of the National Security Council staff and as a consultant to the White House Office on Science and Technology. He co-founded the Institute for Policy Studies in 1963, and at one point served Chairman of the Board of SANE/FREEZE. He is currently a professor of public policy at George Washington University and serves on the editorial board of *The Nation*.

Peter Raven-Hansen is the Glen Earl Weston Research Professor of Law at George Washington University and the former associate dean of the law school. He is the co-author of *National Security Law and the Power of the Purse* (with William C. Banks) and the editor of *First Use of Nuclear Weapons: Under the Constitution, Who Decides?*

John Steinbruner is the director of the Center for International and Security Studies at Maryland (CISSM). He is the author of numerous books, including *A New Concept of Cooperative Security* (with Ashton Carter and William Perry) and most recently, *Principles of Global Security*.
